RESOLUTION RECOMMENDING TO THE SANGGUNIANG BAYAN OF REAL, QUEZON (19TH Council) FOR THE ESTABLISHMENT OF MUNICIPAL CULTURAL HUB (ATENDIDO'S RESIDENCE) LOCATED IN POBLACION 1, REAL, QUEZON

WHEREAS, Article XIV of, Section 14 of the 1987 Philippine Constitution provides that the State shall foster the preservation, enrichment, and dynamic evolution of a Filipino national culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression;

WHEREAS, Section 15 & 16 of Article XIV likewise mandate for the State to conserve, promote and popularize the nation's historical and cultural heritage and resources, as well as artistic creations, thus, it shall be under its protection and its disposition regulated;

WHEREAS, pursuant to the DILG Memorandum Circular No. 81- 2002, there shall be a created Local Council for Culture and the Arts whose main function is to formulate programs and recommendations to develop and sustain local cultural and artistic talents, cultural industries, traditional and contemporary arts and crafts, and their processes;

WHEREAS, based on the approved Tourism Development Plan for 2022- 2030, the municipality of Real shall establish, promote and develop museum which serve as the repository of the rich historical, cultural and natural assets of the town;

WHEREAS, the establishment of Municipal Cultural Hub is one of the priority projects based on the Local Development Investment Plan 2023- 2025;

WHEREAS, the Local Council for Culture and the Arts of Real on its 3rd Quarterly Meeting discussed and proposed to declare the Atendido's Residence as part of the tangible immovable built cultural heritage which serves as the 1st Municipal Building in the Municipality of Real;

WHEREAS, it is our aim to preserve and conserve the built heritage to maintain the vast heritage of Realeños for the present and future generations;

WHEREAS, the Local Council for Culture and the Arts, recommends the establishment of Atendido's Residence as a Municipal Cultural Hub and allot funds for the acquisition of the said property;

NOW THEREFORE- BE IT RESOLVED as the Local Council for Culture and the Arts of the Municipality of Real, Quezon hereby resolve to REQUEST ALLOTMENT OF FUNDS FOR THE ESTABLISHMENT OF MUNICIPAL CULTURAL HUB (ATENDIDO'S RESIDENCE) LOCATED IN POBLACION 1, REAL, QUEZON.

RESOLVED FURTHER to recommend to the Honorable Sangguniang Bayan to make necessary and appropriate actions for the establishment of Municipal Cultural Hub.


