RESOLUTION NO. 2022-431

A RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 037, SERIES OF 2022 OF THE SANGGUNIANG BAYAN OF REAL, QUEZON ENTITLED: "AN ORDINANCE PRESCRIBING A TOURISM USER'S FEE IN THE MUNICIPALITY OF REAL, QUEZON AND FOR OTHER RELATED PURPOSES" AS VALID AND CONSISTENT WITH THE LAW

WHEREAS, Municipal Ordinance No. 037, Series of 2022 of the Sangguniang Bayan of Real entitled: "AN ORDINANCE PRESCRIBING A TOURISM USER'S FEE IN THE MUNICIPALITY OF REAL, QUEZON AND FOR OTHER RELATED PURPOSES" was submitted to the Sangguniang Panlalawigan for review on May 26, 2022 pursuant to the provisions of RA 7160;

WHEREAS, the said ordinance was calendared for First Reading on June 03, 2022 and was referred to the Committee on Tourism, Culture and Arts;

WHEREAS, no action was taken by the Sangguniang Panlalawigan from the time it was received up to present time;

WHEREAS, under Section 56 of the Local Government Code of 1991, the Sangguniang Panlalawigan shall review municipal ordinances and resolutions within 30 days after receipt thereof;

WHEREAS, under the same section, if no action was taken by the Sangguniang Panlalawigan within 30 days after the submission of such ordinance or resolution, the same shall be presumed consistent with law therefore valid;

WHEREAS, since no action was taken by the Sangguniang Panlalawigan on the said ordinance within 30 days from its receipt, the same is hereby deemed approved and presumed to be consistent with law;


NOW THEREFORE, on motion of Hon. John Joseph G. Aquivido unanimously seconded;
